Minutes of Parish Council Meeting held at 8.00pm on Thursday 15th September 2016 in the Village Hall, Wareside

2. Open Forum

3. Planning

Decision Notices Report:

3/16/1614/LBC - Installation of secondary glazing to kitchen, living room, 2 no. bedrooms, stairs and hall at 3 Blakesware Manor Widford Ware Hertfordshire SG12 7RD. Granted consent subject to conditions.

3/16/1551/HH - Single storey front, side and rear extension at 20 Coanwood Cottages Babbs Green Wareside Ware Hertfordshire.

Granted permission subject to conditions.

Applications for consideration:

3/16/2004/FUL - To develop a small scale standby electricity generation plant in a new portal framed building and installation of ancillary equipment at New Hall Farm Newhall Green Fanhams Hall Road Wareside SG12 7SD. All attendees expressed concern and indicated that they were against the development. MR advised Wareside Parish Council will respond but he also requested those present to go onto the planning website to raise their concerns. Open Forum requested that Edge Power Limited hold a public meeting and present the planning request to the Village, MR to arrange. Topics of concern raised and discussed were:

- Pollution
- Increased traffic during construction
- No benefit/financial gain for village
- Safety of an electricity generation plant powered by gas in a rural area
- Exhaust gases and vapor associated with it
- Letter written to 6 properties at one address which looks as if East Herts Council is only treating the properties as a single unit
- Alarm going off at unsociable hours

Maureen Dunn asked if there were any regulations that stipulated minimum proximity of electricity generation plants to dwellings, RN to investigate.

3/16/2021/HH - Proposed single storey rear extension following demolition of existing structure at The Brae Cottage Bakers End Wareside Ware Hertfordshire. No objections raised.
